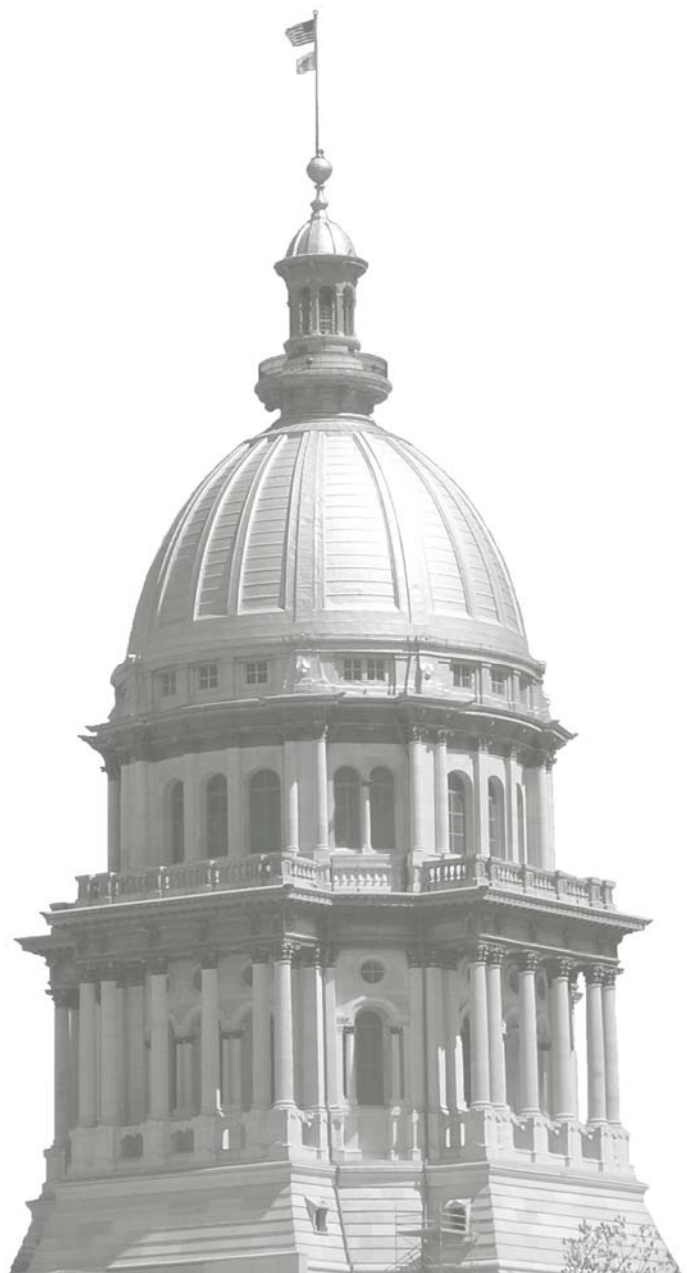

## Executive Summary

Economists and elected officials have suggested the US economy is strong and should be expected to keep growing. The rising tide of economic fortune, however, may not be lifting all boats in postsecondary education. College tuition and costs faced by students and families are still increasing faster than inflation and the available resources of most households. Many public and private institutions are experiencing increased overhead and stagnant or decreasing financial support from nontuition sources. Ensuring that students are able to access the college education so important to their individual success, and so critical for their participation in any national economic achievement, remains a key role of the state and federal student aid partnership.

This report provides data regarding state-funded expenditures for student financial aid and illustrates the importance of efforts made by the states to assist postsecondary students. Information in this report is based on academic year 2004-2005 data from the 36<sup>th</sup> Annual National Association of State Student Grant and Aid Programs (NASSGAP) survey of state expenditures for student financial aid.

### Data Highlights

- In the 2004-2005 academic year, the states awarded about \$7.9 billion in total state funded student financial aid, an increase of more than 8 percent in nominal terms from the \$7.3 billion in aid awarded in 2003-2004 and an increase of about 6 percent in constant dollar terms.
- The majority of state aid is in the form of grants. In 2004-05, slightly more than 3.5 million awards were made representing about \$6.7 billion in need and nonneed-based grant aid, an increase of more than 8 percent from the \$6.2 billion in grants awarded in 2003-2004. Of the grant funds awarded in 2004-05, 73 percent was need-based and 27 percent was nonneed-based. Need-based aid represented about 74 percent of grant aid awarded in 2003-04.
- Funding for undergraduate need-based grant aid increased \$445 million nationwide from about \$4.2 billion in 2003-04 to more than \$4.7 billion in 2004-05, an increase of more than 10 percent.
- Eight states (California, Illinois, Indiana, New Jersey, New York, Ohio, Pennsylvania, and Texas) collectively awarded more than \$3.1 billion in undergraduate need-based grant aid, accounting for about 67 percent of all aid of this type.
- States provided more than \$1.7 billion in nongrant student aid, including loans, loan assumptions, conditional grants, work-study, and tuition waivers. Loans and tuition waivers accounted for 69 percent of nongrant funds awarded.

Forty-four reporting entities identified state-funded undergraduate programs with awards based solely on need, while 22 identified programs with awards based only on merit. Exclusively need-based aid constituted 49 percent of all aid to undergraduates, exclusively merit-based aid accounted for 16 percent, with the rest, 35 percent, accounted for by other programs and by programs with both need and merit components. The amount of undergraduate aid awarded in 2004-05 through programs with a merit component decreased very slightly to just more than \$2 billion. This compares to \$3.5 billion awarded to undergraduates through programs based only on need.

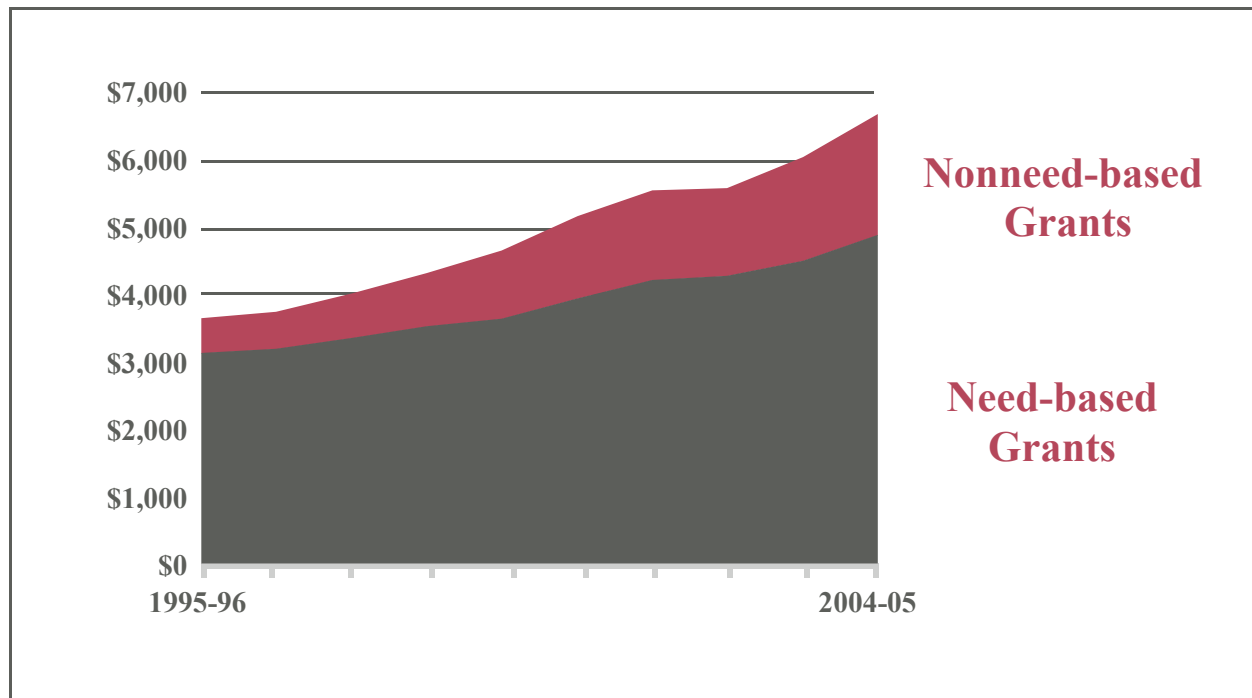
South Carolina, Washington DC, Georgia, New York, and Indiana, provided the greatest amount of grant aid on a per capita basis and the largest amount of aid per capita for the population between ages 18 and 24. South Carolina, Georgia, New York, Kentucky, and New Jersey provided the most undergraduate grant dollars compared to undergraduate full time equivalent enrollment. South Carolina, Georgia, New York, Vermont, and Indiana had the highest proportion of total expenditures for state-funded grants compared to appropriations for higher education operating expenditures.

Constant dollars were calculated using the academic year correction of the Consumer Price Index, All Urban Consumers (CPI-U) from the U.S. Department of Labor, Bureau of Labor Statistics.

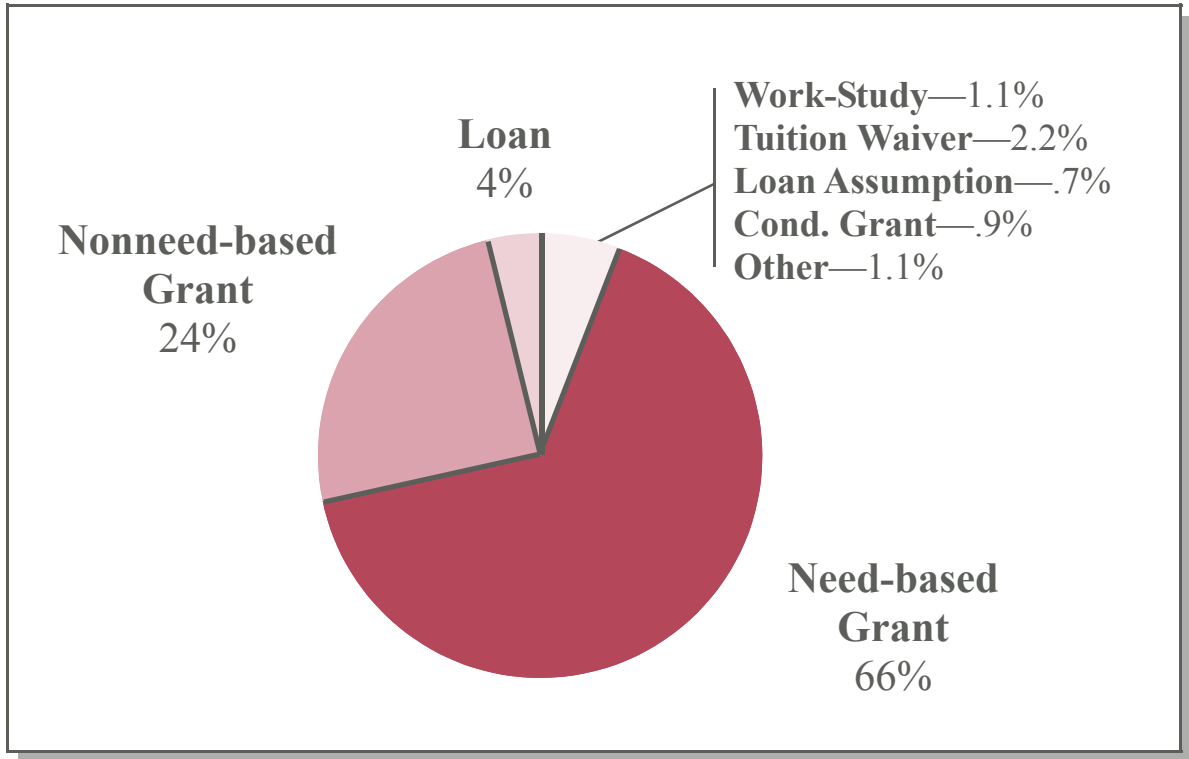

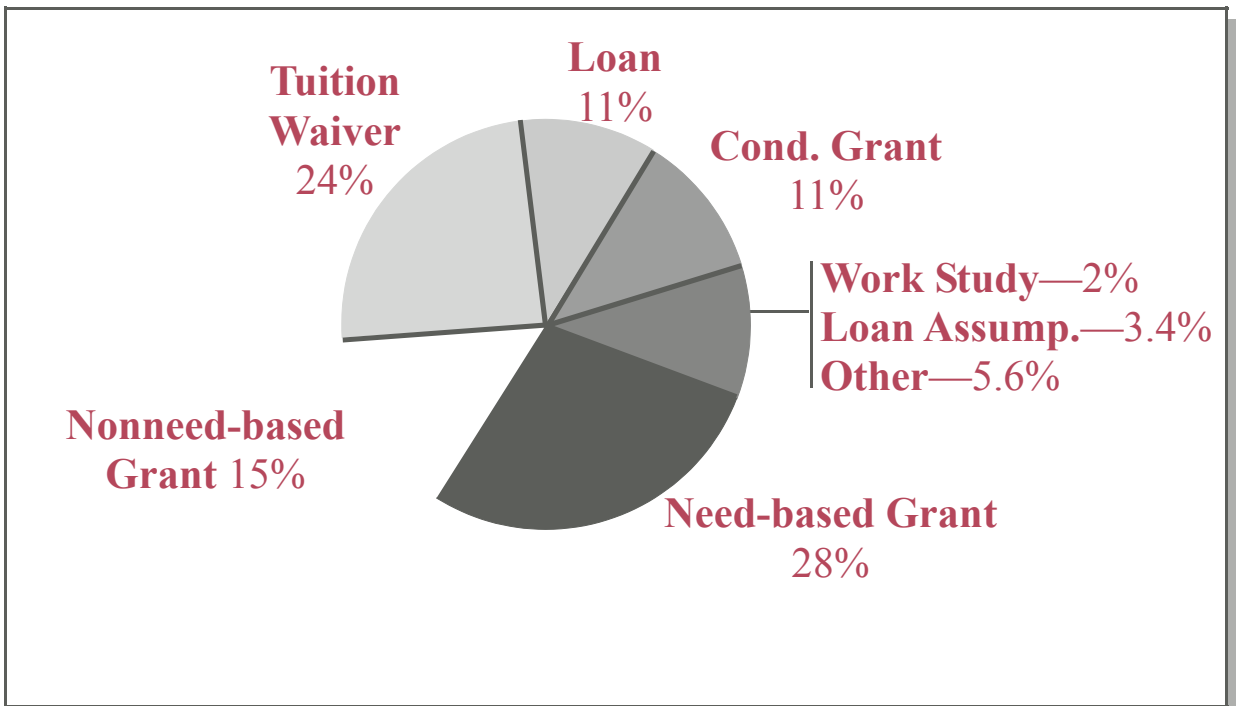

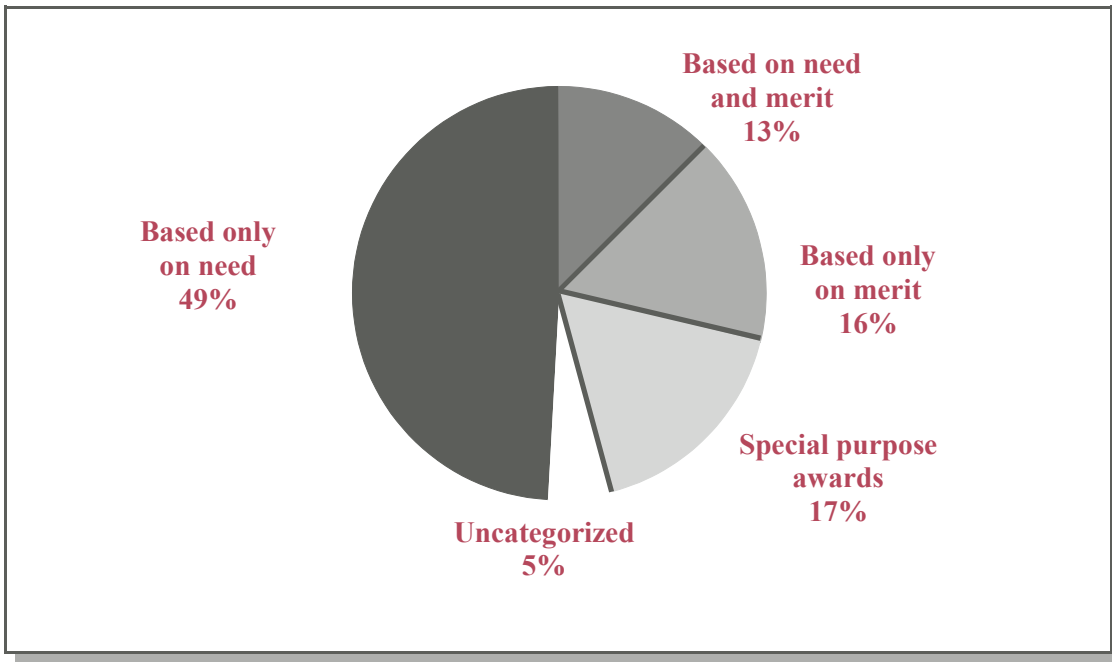
**Figure 1. Undergraduate Aid Dollars, by Type of Aid: 2004-05**



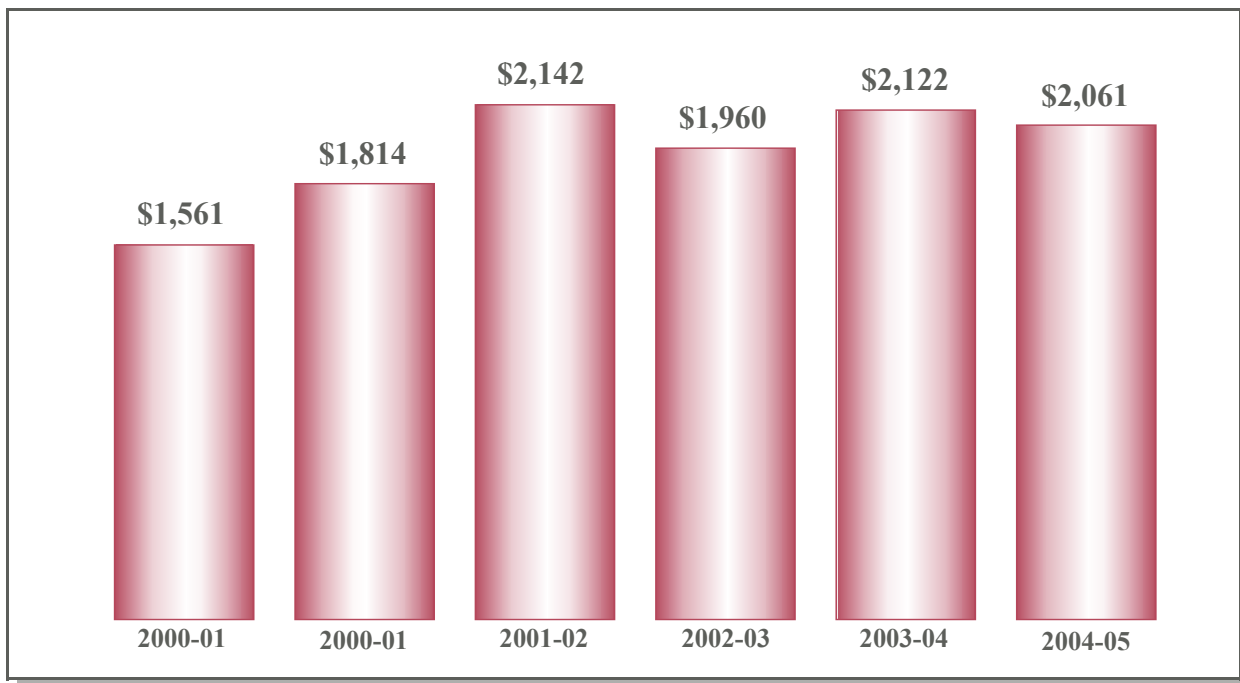
**Figure 2. Graduate Aid Dollars, by Type of Aid: 2004-05**

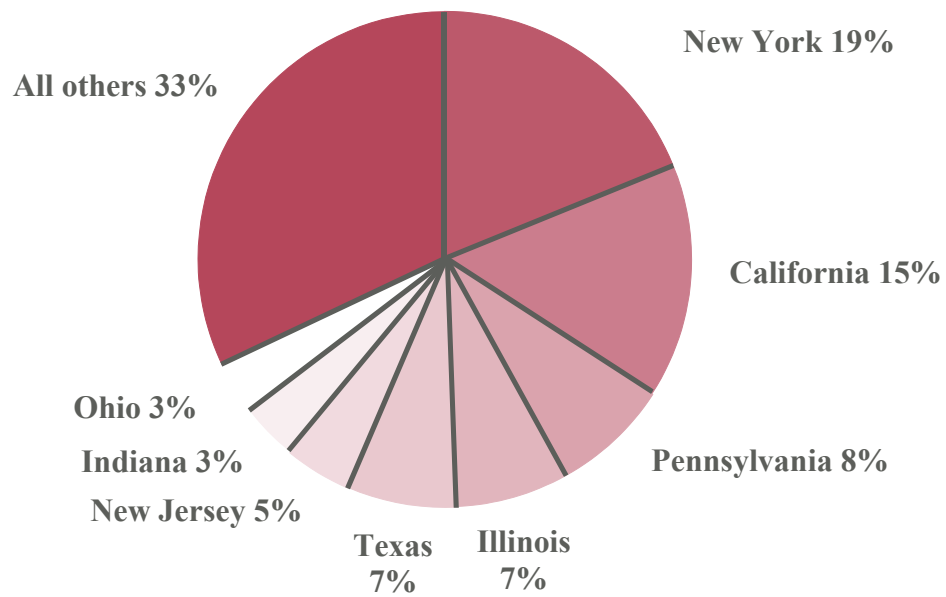

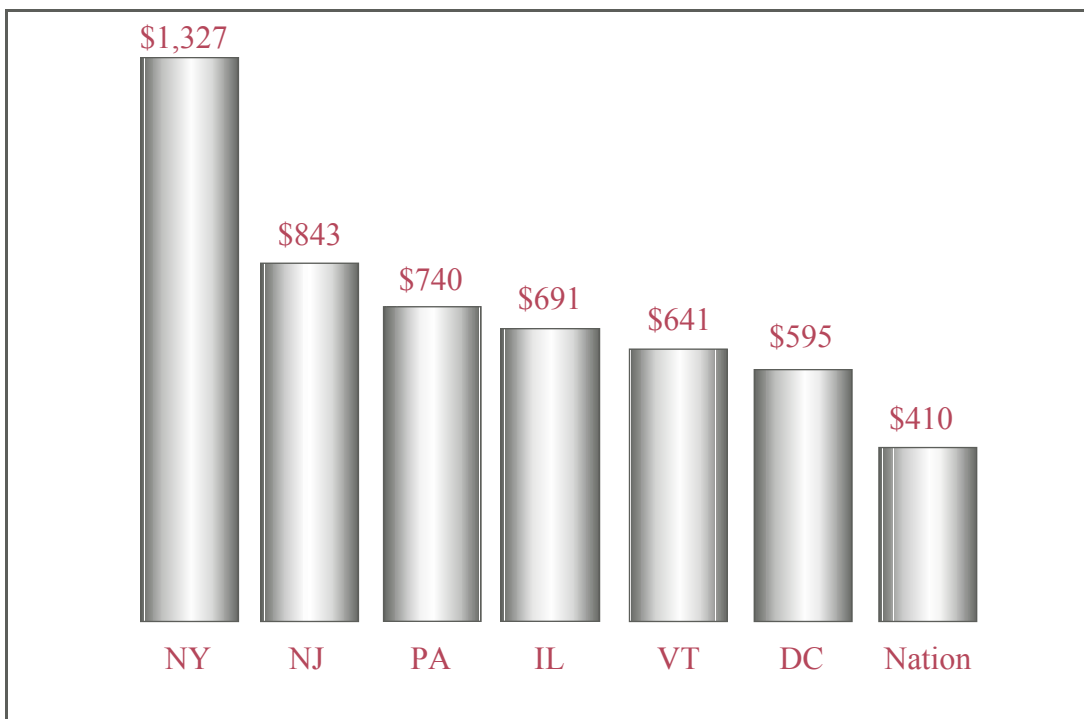

## About the Survey

The 36<sup>th</sup> Annual NASSGAP survey was completed by each state in Winter 2004-05. A PDF version of the survey instrument is available at [www.nassgap.org/survey/NASSGAP\\_Survey\\_Instrument\\_2004-05.pdf](http://www.nassgap.org/survey/NASSGAP_Survey_Instrument_2004-05.pdf). Terms used on the survey instrument include:

*Grant aid:* Includes grants, scholarships and other such gift aid.

*Need-based aid:* Recipients must meet some standard of need using such measures as EFC, remaining costs, or maximum income to be eligible for an award.

*Nonneed-based aid:* Recipients are not required to demonstrate financial need to be eligible for an award.

*Merit based aid:* Recipients are selected in whole or in part on the basis of test score, performance, class rank, grade point average, or other such criteria of achievement.

*Primary need-based grant program:* The flagship need-based grant program in a state. For some states (California, Colorado, Florida, South Carolina), the primary need-based grant program may be a combination of several individual programs.

*Tuition waiver program:* Program mandated or funded by a state in which all or a portion of a recipient's tuition at an eligible institution is not charged to the award recipient.

*Loan assumption or forgiveness program:* Program in which a recipient has the possibility of having a loan repaid or forgiven, in whole or in part, in exchange for fulfilling certain service obligations.

*Conditional grant or loan program:* Recipient receives an award, which will become a loan if certain obligations are not met.

*Special purpose program:* Program with specific objectives usually targeted to specific groups of students. Examples include workforce development programs in which recipients train for particular occupations, such as teachers and health and technical workers; retraining programs aimed at retraining unemployed workers; post-service programs offering benefits to veterans or National Guard members; and, parent or spouse service programs providing benefits to spouses or children of persons killed or disabled during service to the National Guard, police, fire fighters, military, corrections system, or other occupations.

Population data note for Table 11: The 2002-03 NASSGAP Survey Report used July 2002 population estimates. Unfortunately, July 2003 population estimates were not available for the 2003-04 report (last year) and July 2004 figures were substituted. This year's report uses the July 2004 figures as well. It is anticipated July 2005 figures will be utilized for the 2005-06 report.
